#### 6.00 PLANNING ISSUES

- Milliam Lacey (regarding The Villagers), application to remove Section 106 Condition. It was noted that an application had just appeared on the WBC website (WA/2017/0857) for the Working Men's Club, previously referred to as Chiddingfold Ex-Servicemen's Club. William Lacey has applied under Section 106 of the Town and Country Planning Act to modify the legal agreement relating to WA/2010/1252 to remove Schedule 9 of that agreement: "Following the completion of the reconstruction and refurbishment of the Chiddingfold Ex-Servicemen's clubhouse comprised within the Development the Land Owner covenants with the Council that, unless otherwise agreed in writing with the Council as Local Planning Authority, before any change of use it shall use the clubhouse for the sole purposes of a clubhouse for the benefit of Chiddingfold ex-Servicemen and the local community and for no other purpose whatsoever." The Clerk will be asked to put this on the next available agenda.
- 6.02 Tree Works at Middlecott. It was agreed to ask Clerk to write to WBC Tree Officers Andy Clout, Tree Section Manager, Arno Spaarkogel, Senior Tree Officer and also to Matt Lank, Park and Countryside Officer regarding the tree work carried out at Middlecott on School Lane. The Arborist's report on trees growing on or adjacent to Council-owned or Leased land remarked that a native oak tree in the garden of Middlecott, bordering the Coxcombe Lane Recreation Ground, had been extensively reduced but not to an acceptable arboricultural standard:

"T12 has had extensive reduction. The work is not of acceptable arboriculture standard and will cause future tree failure. It is over an electrical cable and the north-west end of St Mary's School playground..."

The Planning Committee would like the WBC Tree Officers who approved the work to look into this and report back on the standard of work carried out and how any deficiency might be rectified.

The Planning Committee felt that WBC should pay more attention to the expertise of the tree surgeons used by residents, especially in the centre of the Conservation Area.

6.03 <u>Lythe Hill Hotel</u>. SF will continue to get answers regarding the removal of trees and the other works being carried out prior to planning permissions being granted.

The Planning Committee usually meets the fourth Thursday of each month. The agenda is posted on the parish main notice board and website. If no planning issues arise, no meeting is held.
